I am responsible for ensuring that my child does not access sites or elicit behavior on the Internet that is considered inappropriate or illegal.
- My child's access to the Internet, using Library computer terminals, is for educational, informational, and recreational purposes only and I agree that the Library is not responsible, in any way, for such information acquired or viewed by my child.
- I hold harmless the Satilla Regional Library System for the sites, the visual, the audio and the printed information that my child will encounter while accessing the Internet with the Library's computers.
- I hereby waive any right I may have to any claim against the Satilla Regional Library System, its employees, trustees, officers and agents arising from my child's use of the Internet.
- I recognize and agree that it is impossible for the Satilla Regional Library System to restrict access to what I would consider controversial and/or inappropriate on the Internet despite the Library's clear intent to do so with the application of filters.

- OPTIONAL: Yes, I give my child the authority to request the removal of the CIPA filter while using the Internet on a library computer. I understand this action may expose my child to material of a graphic or objectionable nature
